## **Research Training**

A key component of the nexus between my teaching and research, is my active engagement in research training and mentoring, at the School level, nationally and internationally.

I have acted as a research mentor and faculty member for two International Research Training Schools (COST Action: Cyberbullying: Turku, Finland; and Melbourne

This is a European tradition of bringing together early career researchers (within 10 years of PhD Completion) with leading researchers in the field, to study intensively with them. The Turku Training school was a one-day intensive adjacent to the main meeting of scholars; but the Melbourne Training school was a week long, and brought together 30 European and 20 Australian ECRs, to study the phenomenon of cyberbullying. Funding was sought from the Department of Innovation, Industry, Science and Research, and matched with the EU funding. (See Boronenko et al, 2013). This was the first time that this had been done outside of Europe.

As part of this innovation, I **taught the Youth Voice component of the curriculum**, bringing 4 young people to work with the ECRs, challenging their notion survey methodologies would necessarily be the best to use for this new phenomenon called cyberbullying.

I was invited to give 2 keynotes and to provide 2 major workshops, and act as Rapporteur for the Early Career Researchers' Forum: Charles Darwin University: May, 2014

This involved working with all researchers collectively to develop their ideas and to explore moving from a research idea, to a research program, with a health-education, industry-nexus.

I convened the New Technologies and Ethics in Wellbeing Research: *National Symposium, April 7<sup>th</sup>*, as part of a joint Wellbeing Research Group and Collaborative Research Network research day, to inform and challenge regarding the ethical issues concerned with researching wit minors in online settings.

**I gave Masterclasses** in qualitative methodologies for cyberbullying research as part of the ECU Collaborative Research Network, for ECRs. I acted as a research mentor:

## **Context for Publications**

Cyberbullying, bullying, sexting, social media and youth voice are cross-disciplinary in nature, calling upon knowledges from education, psychology, sociology, and digital/computing studies and therefore do not fit solely into FOR 13 (Education) or FOR 17 (Psychology). The field of bullying research emerged from aggression studies in the late 1970s, when three boys suicided in Norway. As such, research has been and continues to be most often reported through developmental/psychology publications and quantitative studies dominate the field. There have however been several historical shifts, in terms of research emphasis: from exploring the attributes of the bully and the victim (1970s), to examining gender (late 80s/early 90s); the group dynamic and participant roles (late 90s); and most recently the risk and protective factors; the role of bystanders, and the cross-cultural contexts. With the emergence of cyberbullying, prevalence key factors are again being explored, but as technology changes, so too do the forms of behaviour. (See Non-refereed-Industry papers: Spears 2009; 2010)

My research began by exploring girls' bullying behaviours (PhD, 2005), and was followed by wide consultations to schools and community locally and naturally, in terms of school and government policy development (See Engagement). It naturally shifted to examining covert and cyberbullying, as bullying moved behind the scenes and screens. (See Spears et al, 2008; 2009). I also examined the positive uses of technology to support young people (See Costabile & Spears, 2012; Cross et al 2013; Spears et al 2013); and as technology became ubiquitous, the role of using it as intervention strategies was both highly innovative and challenging (See Spears et al 2015a; 2016).

My most significant contribution has been in bringing *youth voice* to the fore when exploring cyberbullying and sexting: as these are not behaviours most adults have experienced). To that end, I have challenged the reliance largely on quantitative studies (See Spears & Kofoed, 2013). (See Research Experiences and Achievements).

Finally with the shift to digital, my research has explored new ways of intervening, and I have published with industry partners and experts in the digital marketing field (See Spears & Zeederberg, 2013; Spears et al, 2013; Spears et al, 2012)

It brought together 17 chapters from the leading researchers in the field from 10 different countries in Europe and Australia, highlighting the positive aspects of ICTs, and advocating for social supports and learning opportunities which can be delivered through technology. As the English speaking editor, I edited all chapters, sent them out for, and engaged in double-peer review, and wrote the Introduction and Conclusion, in consultation with my coauthor.
